## LEV'S "FUEL UP WITH SELENA & CROCKETT" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

- 3. **How to Enter.** Follow 100.7 LEV on Instagram @<u>https://www.instagram.com/1007wlev/</u>. Each weekday morning, during the Contest Period, Selena & Crockett will create a post that will include the WLEV and PE Honda logos, a keyword and short code 68683 to text for a chance to win. Participants should text the provided keyword to 68683 to be eligible for a chance to win a prize. **Message and data rates may apply. Entrants agree to receive messages from Station from time to time relating to the Contest. Limit one (1) entry per person per phone number.**
- 4. **Winner Selection.** Each weekday during the Contest Period, the first person to successfully text the correct keyword with correct spelling will automatically win a \$10 digital Wawa gift card. Bounce back message will instruct winner to contact 100.7 LEV to receive their digital Wawa gift card. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification will result in disqualification and forfeiture of the prize.
