WLEV "ED SHEERAN WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the **100.7 LEV "Ed Sheeran Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Contest Period. The Contest entry period will be **Friday**, **November 25**, **2022** at 3:00pmET and will **run** through **Sunday**, **November 27**, **2022** at **11:59pmET** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

2. **How to Enter.**

<u>Text</u>: Send a text message with the keyword CHRISTMAS spelled correctly to 6-8-6-8-3 during the Contest Period. All entries must be received by 11:59pmET on November 27, 2022 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

Winner Selection. On or about Monday, November 21, 2022 the Station will select one (1) potential winner(s) each day in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 3. Verification of Potential Winner.
