WLEV'S "TICKET THURSDAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WLEV (the "Station"), 2158 Avenue C, Suite 100, Bethlehem PA 18017, during available business hours Monday through Friday, Station website www.wlevradio.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct **WLEV's Ticket Thursday**" Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - Contest Period. The Contest entry period will begin approximately at 6:00 am ET on Thursday, April 6, 2023 and run through 11:55pm ET on Thursday, April 6, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter and Win.**

Listen to the Station during the Contest Period. Between 6am and 11:55pm, on Thursday, March 30, 2023, when the Station announces keyword, listeners must text correct keyword to the Station at 610-720-1007. One random winner will be selected among all eligible entries as the winner. Winner will be subject to verification and compliance with these Contest Rules. Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
